WHEREAS, the Provincial Government of Isabela considers all local government units in the Province of Isabela as institutional partners in the attainment of its goal of achieving genuine, comprehensive, and lasting progress;

WHEREAS, this Honorable Body recognizes that local government units have good understanding of the conditions and circumstances within their territorial jurisdictions, including the status of local roads and traffic situations, among others;

WHEREAS, submitted for the consideration of this Honorable Body is Sangguniang Bayan Resolution No. 2020-003 duly enacted by the Municipality of Quezon, Isabela, requesting for the conversion and declaration of the Quezon-Sto. Tomas Road into a Provincial Road;

A RESOLUTION FAVORABLY ENDORSING TO THE SECRETARY OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS THE REQUEST OF THE MUNICIPALITY OF QUEZON, ISABELA FOR THE CONVERSION OF THE QUEZON-STO. TOMAS MUNICIPAL ROAD INTO A PROVINCIAL ROAD

WHEREAS, to review the legality of the aforesaid request, this Honorable Body referred the Resolution to the Provincial Legal Office (PLO) for any legal commentary or opinion. Upon further evaluation of the antecedent facts and documents presented, the PLO is of the opinion that since the DPWH Department Order No. 133 of 2018 was silent as to the requirements for converting Local Roads to other classification of Local Roads (i.e. Municipal Road to Provincial Road, *"the conversion of the Municipal Road subject of the Resolution into a Provincial Road can be legally made"*);

WHEREAS, this Honorable Body recognizes that the road interconnecting the Municipality of Santo Tomas, Isabela and other northwestern municipalities of Isabela is viewed as favorable and beneficial to all Isabelinos in transporting their local products to the market and the goal to maximize economic activities would be accomplished;

WHEREAS, acknowledging the authority of the Department of Public Works and Highways to classify roads and highways, and to provide and authorize the conversion of roads and highways from one category to another, this Honorable Body hereby endorses to the DPWH Secretary, Honorable Manuel M. Bonoan, the conversion of the herein provided Municipal Road into a Provincial Road;

WHEREAS, premises considered, upon motion of Honorable Victor G. Dy, duly approved and seconded in a session duly assembled, it was -

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION FAVORABLY ENDORSING TO THE SECRETARY OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS THE REQUEST OF THE MUNICIPALITY OF QUEZON, ISABELA FOR THE CONVERSION OF THE QUEZON-STO. TOMAS MUNICIPAL ROAD INTO A PROVINCIAL ROAD.

RESOLVED FINALLY, that a copy of this Resolution be furnished to the Provincial Governor, Hon. Rodolfo T. Albano III, and Hon. Manuel M. Bonoan, Secretary of the DPWH, for their guidance and consideration.


