WHEREAS, after careful review of the proposed Elevator Maintenance and Service Contract, this Honorable Body finds the same to be just, lawful, and in consonance with the policies of the Provincial Government of Isabela;

WHEREAS, Section 465, par. (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;
