**WHEREAS**, Section 16 of the Local Government Code of 1991 empowers Local Government Units to exercise all powers necessary for the promotion of the general welfare of their people;

**WHEREAS**, taking into consideration that the Province of Isabela is susceptible to the effects of various natural disasters and calamities, the Provincial Government of Isabela adopts proactive measures to ensure the effective implementation of its disaster preparation and response mechanisms;

**WHEREAS**, Republic Act No. 1190 established the Office of Civil Defense which serves as the implementing arm of the National Disaster Risk Reduction and Management Council and is primarily tasked to administer comprehensive national civil defense and disaster risk reduction and management programs;

**WHEREAS**, the Office of the Civil Defense implements a program in which it prepositions Non-Food Items to Local Government Units to promptly address the basic needs of their constituents in times of disasters or calamities;

**WHEREAS**, submitted for the consideration of this Honorable Body is the proposed Memorandum of Agreement between the Provincial Government of Isabela and the Office of the Civil Defense Regional Office 02 which will enable the prepositioning of Non-Food Items in the Province of Isabela to ensure the extension of timely and necessary relief to disaster victims and evacuees;

**WHEREAS**, after careful review of the proposed Memorandum of Agreement, this August Body finds the same to be just, lawful, and in line with the disaster preparation, resilience, management, and response policies of the Provincial Government of Isabela;

**WHEREAS**, Section 465, par. (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

**WHEREFORE**, upon motion of Hon. Victor G. Dy, duly approved and seconded in a session duly assembled, it was –

**RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
