ALBANO III, TO SIGN ON BEHALF OF THE CAUAYAN DISTRICT HOSPITAL OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH CAGAYAN VALLEY MEDICAL CENTER REGIONAL BLOOD CENTER FOR THE ESTABLISHMENT OF A BLOOD RESERVE AUGMENTATION PARTNERSHIP

WHEREAS, the Provincial Government of Isabela (PGI) upholds a policy that aims to protect and promote the health of its people. In line with this policy, it ensures the availability of local blood reserves by ensuring that licensed blood service facilities have adequate staff, equipment, and resources to perform all their functions safely, efficiently, and effectively;

WHEREAS, national blood supplies for transfusion are experiencing a sharp decline. As such, local blood reserves are facing a shortage. To address this, the PGI, through the Cauayan District Hospital (CDH), expressed its interest to partner with the Cagayan Valley Medical Center Regional Blood Center (CVMC-RBC), which shall serve as the source of blood for transfusion, to ensure that local patients receive adequate, affordable, and safe blood and blood components;

WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Memorandum of Agreement between the CVMC-RBC and the PGI which will establish such a blood supply partnership;

WHEREAS, Section 465(b)(1)(vi) of the Local Government Code of 1991 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents relative to the execution of his functions, upon authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, after a careful review, this Honorable Body determined that the Memorandum of Agreement between the PGI and the CVMC-RBC to be just and lawful and beneficial for the Province;

WHEREFORE, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was -
