T-372124 BEARING LOT NO. 7040-A-3,Psd-(af)-02-033890 COVERING AN AREA OF ELEVEN THOUSAND NINE HUNDRED EIGHTY TWO (11,982) SQUARE METERS, MORE OR LESS, SITUATED AT BARANGAY DARAMUANGAN SUR, SAN MATEO, ISABELA, FROM AGRICULTURAL TO NON-AGRICULTURAL USE."

WHEREAS, Section 20 (a) of R. A. 7160 or the Local Government Code of 1991 grants a municipality the power to authorize the reclassification of agricultural lands into a residential, commercial or industrial purposes and was more specifically stated as follows:

A RESOLUTION UPHOLDING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 2022-857 OF THE MUNICIPALITY OF SAN MATEO, ISABELA, ENTITLED, "AN ORDINANCE APPROVING THE RECLASSIFICATION OF A CERTAIN PARCEL OF LAND WITH TRANSFER CERTIFICATE OF TITLE (TCT) NO. T-372124 BEARING LOT NO. 7040-A-3,Psd-(af)-02-033890 COVERING AN AREA OF ELEVEN THOUSAND NINE HUNDRED EIGHTY TWO (11,982) SQUARE METERS, MORE OR LESS, SITUATED AT BARANGAY DARAMUANGAN SUR, SAN MATEO, ISABELA, FROM AGRICULTURAL TO NON-AGRICULTURAL USE."

"A city or municipality may, through an ordinance passed by the sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in

the following cases: (1) when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the sanggunian concerned."

WHEREAS, on June 14, 2022, Municipal Ordinance No. 2022-857 was enacted by the Sangguniang Bayan of San Mateo, Isabela, reclassifying a land containing an area of 11,982 sq.m., more or less, covered by Transfer Certificate of Title no. T-372124 bearing lot no. 7040-A-3,Psd-(af)-02-033890 situated at Barangay Daramuangan Sur, San Mateo, Isabela;

WHEREAS, Section 3 of the Memorandum Circular No. 54, Series of 1993, of the Office of the President provides that, "All ordinances authorizing the reclassification of agricultural lands shall be subject to the review and approval by the province in the case of component city or municipality";

WHEREAS, having been authorized to review ordinances reclassifying agricultural lands under the abovesaid Memorandum Circular, the Committee on Housing, Subdivision and Land Use Classification conducted a thorough review of Ordinance No. 2022-857 of the Municipality of San Mateo, Isabela, and finds the same to be in consonance with the mandate of the Sangguniang Bayan pursuant to Section 20 of R.A. No. 7160. Thus, said ordinance is within the purview of the powers conferred by law to their Sangguniang Bayan;

WHEREAS, the Committee recommended to the Body to uphold the validity of Ordinance No. 2022-857 of the Municipality of San Mateo, Isabela;

WHEREFORE, upon motion of HON. MARY GRACE D. ARREOLA, duly approved and seconded in a session duly assembled, it was –
