ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A DEED OF DONATION FOR THE DONATION OF MATERIALS IN FAVOR OF COMPONENT CITY AND MUNICIPAL GOVERNMENT UNITS AND NATIONAL GOVERNMENT AGENCIES IN THE PROVINCE OF ISABELA TO BE UTILIZED FOR THE CONSTRUCTION OF COVID-19 ISOLATION FACILITIES

WHEREAS, it is the policy of the Provincial Government of Isabela to promote and safeguard the health of its people;

WHEREAS, the COVID-19 pandemic caused serious disruptions and devastation to the country's communities, healthcare system, and economy;

WHEREAS, going through the hardships brought about by the COVID-19 pandemic, the Provincial Government of Isabela gained valuable experience in addressing infectious diseases. Resultantly, it acknowledges that there is a continuing need to improve its capacity to promptly resolve health issues of immediate concern;

WHEREAS, in pursuit of its goal of improving its capacity to promptly resolve health issues, such as COVID-19, and prevent unnecessary losses to life and resources in case such a dire event reoccurs, the Provincial Government of Isabela sees the need to maintain and increase the capacity of local government units and national government agencies in the Province of Isabela to contain and address health issues within their respective jurisdictions;

WHEREAS, recognizing such a need, the Provincial Government of Isabela aspires to donate materials to component city and municipal government units and national government agencies in the Province of Isabela for the construction of isolation facilities;

WHEREAS, submitted for the review and approval of this August Body is a pro-forma deed of donation which will be utilized by the Provincial Government of Isabela (PGI) in entering into donation agreements with various component city and municipal government units and national government agencies in the Province of Isabela in which the PGI will donate to the said government institutions materials for the construction of isolation facilities;

WHEREAS, under Section 465(b)(1)(vi) of the Local Government Code of 1991, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the aforesaid Deed of Donation on behalf of the Provincial Government of Isabela;

WHEREAS, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T. 
