A RESOLUTION ADOPTING EXECUTIVE ORDER NO. 38, SERIES OF 2022 DESIGNATING THE PROVINCIAL VICE GOVERNOR, THE HONORABLE FAUSTINO G. DY III, AS THE DIRECTOR GENERAL OF THE 2023 BAMBANTI FESTIVAL CELEBRATION

WHEREAS, the Provincial Governor, the Honorable Rodolfo T. Albano III, issued Executive Order No. 38, series of 2022 **Designating the Honorable Faustino G. Dy III as Director General of the 2023 Bambanti Festival Celebration;**

WHEREAS, the Director General of the Bambanti Festival Celebration serves as the partner of the Provincial Governor in setting and directing the course for the Provincial Government of Isabela in the planning and implementation of activities for and in furtherance of the 2023 Bambanti Festival Celebration. Also, as provided in Section 2 of the said Executive Order, the Director General shall have the following functions:

1. Serve as the Provincial Governor's Chief Executive Officer on matters relative to the 2023 Bambanti Festival;
2. Direct the planning and implementation of initiatives arrived at by the 2023 Bambanti Festival Organizing Committee;
3. Advise the Provincial Governor on developments from the planning, preparation, and implementation stages of the festival;
4. Contribute their skills and valuable experience in the implementation of the various phases of the festival/celebration;
5. Act as on-site and off-site Executive Officer throughout the different phases of the festival;
6. Sign for and in behalf of the Governor any and all contracts related to the festival;
7. Assist the Provincial Governor in the assessment and review of the project implementation to ensure its consistency with the government policy on the preservation and promotion of culture and tradition;
8. Work directly with the Governor and submit to him any observation, recommendation, and any information pertinent to the 2023 Bambanti Festival;
9. Appoint an Assistant Director General as he deems fit and necessary and create other committees as needed and proper under circumstances.

WHEREAS, the Provincial Vice Governor, the Honorable Faustino G. Dy III, expressed his acceptance to the said designation and in performing the functions attached to such a position;

WHEREAS, this August Body determined that adopting Executive Order No. 38, series of 2022 issued by the Provincial Governor, the Honorable Rodolfo T. Albano III, advances those decreed in Sangguniang Panlalawigan Ordinance No. 10, series of 2012 and is beneficial to the Province of Isabela;

WHEREFORE, upon motion of the Honorable Mary Grace D. Arreola, duly approved and seconded in a session duly assembled, it was –
