WHEREAS, Ordinance No. 2022-471, an Ordinance approving Supplemental Budget No. 04 for Fiscal Year 2022 in the amount of FOUR HUNDRED TWELVE MILLION FOUR HUNDRED EIGHTY FIVE THOUSAND PESOS (P412,485,000.00) from New Revenue Source of loan proceeds to be allocated and utilized for the Construction of Multi-Purpose Building, Road Concreting and Road Reblocking of the City Government of Cauayan, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

**NOW THEREFORE**, on motion of SP Member **DELFINITO EMMANUEL L. ALBANO** duly seconded:

### THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 2022-471 of the City of Cauayan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- 1. That the Four Hundred Twelve Million Four Hundred Eighty Five Thousand Pesos (P412,485,000.00) loan of the City of Cauayan, Isabela, must be governed by Sec. 324 (b) of RA 7160, which states:
  - "That the amount of Appropriations for debt servicing shall not exceed twenty percent (20%) of the regular income of the LGU concerned."
- 2. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations;

**RESOLVED FURTHER**, to require the City of Cauayan, Isabela to comply with the herein review findings/conditions.

**RESOLVED FURTHERMORE**, to inform the City of Cauayan, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable CESAR S. DY, JR.**, City Mayor, and to the Sangguniang Panlungsod of the City of Cauayan, Isabela, through the **Honorable LEONCIO A. DALIN, JR.**, City Vice-Mayor.
