**WHEREAS**, in formulating its policies and carrying out its programs, the Provincial Government of Isabela gives primary consideration to the growth of the local agricultural sector and the welfare of its farmers;

**WHEREAS**, to advance its goals, the PGI actively works to establish partnerships with institutions and organizations to ensure a productive and profitable local livestock and poultry industry, as well as to foster market-oriented raisers that will produce high-quality goods;

**A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT PROVIDING FOR THE IMPLEMENTATION OF THE LIVELIHOOD ASSISTANCE PROGRAM FOR THOSE AFFECTED BY THE AFRICAN SWINE FEVER AND THEIR RESPECTIVE LOCAL GOVERNMENT UNITS**

**WHEREAS**, the African Swine Fever (ASF) is a highly contagious viral disease that affects pigs and wild boars. It causes high mortality rates and is having a devastating impact on the nation's swine industry, which has in turn slowed the expansion of the agricultural sector. Consequently, it caused a 17% drop in the sector's output as per Philippine Statistics Office;

**WHEREAS**, pursuant to the Department of Agriculture's (DA) Administrative Order No. 06-2021 also known as "Guidelines on the Implementation of the Recovery, Rehabilitation, And Repopulation Assistance Program for ASF Affected and Non-Affected Areas," states that rehabilitation and repopulation are required to be able to restore the swine population and stabilize pork prices;

**WHEREAS**, the PGI recognizes the current dilemma of the swine-raising industry. To address such a dilemma, the PGI, in partnership with the DA, will jointly implement the Recovery and Repopulation Program/Livelihood Assistance to ASF-affected swine raisers in the province of Isabela";

**WHEREAS**, the project's primary objectives are to expand local swine inventories in the province, assist the DA and other government agencies' swine-based livelihood programs, and provide farmers additional resources;

**WHEREAS**, submitted for the review and approval of this Honorable Body is the proposed Memorandum of Agreement providing for the implementation of the ASF livelihood program. In such an agreement, the PGI will provide assistance to those affected by the ASF in the Province of Isabela and work with their local government units on matters concerning monitoring and facilitating the implementation of the said program;

**WHEREAS**, after careful review, this August Body determines the Memorandum of Agreement to be just and lawful and that granting the Provincial Governor the necessary authority to sign the same on behalf of the Provincial Government of Isabela is beneficial to Isabeleños and promotive of their welfare, and furthers the Province's goals relative to the advancement of the local agriculture sector;

**WHEREAS**, Section 465(b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of authority by the Sangguniang Panlalawigan;

**WHEREFORE**, upon motion of the Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was –

**RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT PROVIDING FOR THE IMPLEMENTATION OF THE LIVELIHOOD ASSISTANCE PROGRAM FOR THOSE AFFECTED BY THE AFRICAN SWINE FEVER AND THEIR RESPECTIVE LOCAL GOVERNMENT UNITS**


