A RESOLUTION EXPRESSING THE APPROVAL OF THE PROVINCIAL GOVERNMENT OF ISABELA ON THE CONVERSION OF THE TUMAUINI-DELFIN ALBANO ROAD FROM A PROVINCIAL ROAD TO A NATIONAL ROAD AND REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO APPROVE SUCH A CONVERSION

WHEREAS, it is the policy of the Provincial Government of Isabela to improve the quality of living of all Isabeleños and to identify and implement all the necessary, appropriate, and lawful measures that will spur economic progress in the province;

A RESOLUTION EXPRESSING THE APPROVAL OF THE PROVINCIAL GOVERNMENT OF ISABELA ON THE CONVERSION OF THE TUMAUINI-DELFIN ALBANO ROAD FROM A PROVINCIAL ROAD TO A NATIONAL ROAD AND REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO APPROVE SUCH A CONVERSION

WHEREAS, the Tumauini-Delfin Albano Road is a provincial road that connects the municipalities of Tumauini and Delfin Albano. It plays a crucial role in the development of the communities and barangays of both local government units and contributes to the attainment of their economic potential;

WHEREAS, the Provincial Government of Isabela acknowledges the significance of the Tumauini-Delfin Albano Road in bringing progress and prosperity to its surrounding area. Correspondingly, it is receptive to the institution of any act, move, or measure that will result in the improvement of such infrastructure. One such act that the Provincial Government of Isabela considers is the conversion of the Tumauini-Delfin Albano Road from a Provincial Road to a National Road;

WHEREAS, the conversion of the Tumauini-Delfin Albano Road from a Provincial Road to a National Road will raise its capacity to bring progress and prosperity to the areas surrounding such an infrastructure and uplift the lives of the Isabeleños;

WHEREAS, Executive Order No. 124, series of 1987 authorized the Department of Public Works and Highways to classify roads and highways into national, regional, provincial, city, municipal, and barangays roads and highways and to provide or authorize the conversion of roads and highways from one category to another;

WHEREAS, in line with such a grant of authority, the Department of Public Works and Highways issued Department Order No. 133, series of 2018 with the subject "Criteria and Guidelines for Road Conversion from Local to National Roads and Vice Versa". Such an order provides the set of criteria and guidelines, to be implemented by the Department of Public Works and Highways, for the evaluation of roads for conversion from local to national and vice versa;

WHEREAS, Section III of Department Order No. 133, series of 2018 provides that the request or proposal for conversion of a local road into a national road or vice-versa must be supported by a Resolution duly passed for such purpose by the appropriate local legislative board;

WHEREAS, the Provincial Government of Isabela, through this resolution, expresses its clear and certain stand that it is amenable to the turnover or conversion of the Tumauini-Delfin Albano road in favor of the National Government, undertakes that it will be responsible for the acquisition of the minimum twenty (20) meter road right-of-way (RROW) requirement of a national road, and that it will defend the National Government and the Department of Public Works and Highways against the claims of any person that may arise from the acquisition of the RROW, conversion of the road, or any concerns relative thereto;

WHEREAS, this endeavored conversion being beneficial to the Isabeleños and furthers the common goals of the Provincial Government of Isabela and the Department of Public Works and Highways (DPWH), the August Body is hopeful that such a proposal will merit the approval of the DPWH;

WHEREFORE, upon motion of the Honorable Victor G. Dy, duly approved and seconded in a session duly assembled, it was –
