#### **EXPLANATORY NOTE**

The Provincial Government of Isabela is committed to upholding the Isabeleño's constitutional rights to life and property by addressing, among others, the root causes of vulnerabilities to disasters, strengthening the province's institutional capacity for disaster risk reduction and management, and building the disaster resilience of local communities to disasters including climate change impacts.

Acting in line with this commitment and with due consideration to the proneness of the Province of Isabela to natural disasters and the effects of climate change due to its geographical

location, the Provincial Government of Isabela implements programs, projects, and activities (PPAs) aimed at further enhancing its disaster preparedness, management, and response capacity

On November 10, 2023, the Provincial Disaster Risk Reduction and Management Council of the Province of Isabela convened and issued Council Executive Committee Resolution No. 01-2023. This resolution approved the reprogramming of funds within the 2023 LDRRM Fund Provincial Government of Isabela amounting to Php29,000,000.00 to fund the implementation of the Project/Program/Activity (PPA) "Other PPE- Disaster Equipment".

To fund this PPA, the Provincial Disaster Risk Reduction and Management Council has identified funds within the 2023 LDRRM Fund of the Provincial Government of Isabela which are available for reprogramming pursuant to Item Nos. 6.4 and 6.5 of NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated 25 March 2013.

Given the considerable advancement to the disaster management and disaster resilience that the province will gain from this reprogramming and the legality and appropriateness of the proposed financing method, this August Body strongly supports the request of the Honorable Governor for the reprogramming of such funds, hence this ordinance.

**Section 5. Effectivity.** This Ordinance shall take effect immediately upon its approval.




