**A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF LUCKY TAYA GAMING CORPORATION TO CONDUCT E-BILLIARD OPERATIONS IN THE PROVINCE OF ISABELA, WITHOUT PREJUDICE TO THEIR COMPLIANCE WITH OTHER PERMITS AS MAY BE REQUIRED BY THE CITY AND MUNICIPAL LOCAL GOVERNMENT UNITS WITHIN THIS TERRITORIAL JURISDICTION**

**WHEREAS**, the 1987 Philippine Constitution establishes the State policy on the encouragement of sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry;

**A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF LUCKY TAYA GAMING CORPORATION TO CONDUCT E-BILLIARD OPERATIONS IN THE PROVINCE OF ISABELA, WITHOUT PREJUDICE TO THEIR COMPLIANCE WITH OTHER PERMITS AS MAY BE REQUIRED BY THE CITY AND MUNICIPAL LOCAL GOVERNMENT UNITS WITHIN THIS TERRITORIAL JURISDICTION**

**WHEREAS**, in line with such State policy and its local health promotion strategies, the Provincial Government of Isabela actively supports and implements programs that encourage its people to appreciate and participate in sports and physical activities;

**WHEREAS**, billiards is a form of sport that many Filipinos, regardless of social standing, engage in or tune into. Verily, among the many sports in which the Philippines has competed internationally, billiards has given the country the most success. Due to various Filipinos' triumphant history in the sport, the Philippines has earned its title as the pool capital of the world;

**WHEREAS**, however, the country's success in billiards has gradually waned in recent years due to the lack of promotion. Considering its contributions to highlighting the skills of Filipinos in the international scene and its ability to provide entertainment to our people, efforts must be carried out to revitalize the sports of billiards and the billiards industry;

**WHEREAS**, submitted for the review and approval of this August Body is a letter from Lucky Taya Gaming Corporation, an entity duly organized and recognized by the Securities and Exchange Commission and duly licensed by the Philippine Amusement and Gaming Corporation, requesting for the passage of a resolution interposing no objection to the conduct of E-billiard operations in the Province of Isabela;

**WHEREAS**, e-billiards is a mechanism by which duly organized billiard tournaments or matches competed in real-time by duly licensed billiard players in duly permitted billiard halls in the country are streamed on a duly licensed streaming platform. E-billiards facilitate public viewing of billiards as such it acts as a sports promotion medium that can revitalize the public's appreciation to the sport of billiards and the billiards industry;

**WHEREAS**, with due regard to the status of Lucky Taya Gaming Corporation as an entity duly organized with the Securities and Exchange Commission and duly licensed by the Philippine Amusement and Gaming Corporation to operate e-billiards betting platforms or systems, the ability of e-billiards to foster public appreciation to the sport of billiards which the country is internationally famous for, and provided that the kiosks and terminals established by Lucky Taya Gaming Corporation for such purpose are operated in an off-hall betting station that has complied with LGU permit requirements and has secured a Letter of No Objection from the concerned local chief executive, this August Body finds no cogent reason to raise objections to or oppose the conduct of e-billiard operations in the Province of Isabela;


