**A RESOLUTION DECLARING ORDINANCE NO. 2023-238 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF SAN MANUEL, ISABELA AS VALID**

**WHEREAS**, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to “review all ordinances approved by the sangguniang of component cities and municipalities” and to “determine whether these are within the scope of the prescribed powers of the sanggunian”;

**WHEREAS**, submitted for the review of this August Body is Ordinance No. 2023-238 of the Municipal Local Government Unit of San Manuel, Isabela (MLGU San Manuel) titled “An Ordinance Authorizing the Proposed Borrowing of the Municipality of San Manuel, Isabela with the Land Bank of the Philippines in the Amount of Forty Million Pesos (Php40,000,000.00) to Fund the LGU San Manuel Project: Construction of Sanitary Landfill with Access Road and Three Phase Line”;

**A RESOLUTION DECLARING ORDINANCE NO. 2023-238 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF SAN MANUEL, ISABELA AS VALID**

**WHEREAS**, as stated in the Ordinance, MLGU San Manuel will enter into a Loan Agreement with the Land Bank of the Philippines for the amount of Forty Million Pesos (P40,000,000.00) to finance the construction of a sanitary landfill with an access road and three-phase line. As certified by their Sangguniang Bayan, such a project is in accordance with their local development plan and public investment program and is supported by a feasibility study prepared by their Municipal Environment and Natural Resources Office through their Ten (10) Year Municipal Ecological Solid Waste Management Plan that is approved through San Manuel Sangguniang Bayan Resolution No. 2015-034;

**WHEREAS**, Section 297(a) of the Local Government Code allows local government units to contract loans, credits, and other forms of indebtedness with any government or domestic private bank and other lending institutions to finance the construction, installation, improvement, expansion, operation, or maintenance of public facilities, infrastructure facilities and the implementation of other capital investment projects, subject to such terms and conditions as may be agreed upon by the local government unit and the lender;

**WHEREAS**, this August Body recognizes that local government units possess direct information concerning the needs of their citizens and the conditions within their jurisdiction and thus are in the best position to identify the programs and projects that will advance the welfare of their people;

**WHEREAS**, after careful review and with due consideration to the recommendation of the Provincial Budget Office interposing no objection and stating no adverse finding to MLGU San Manuel Ordinance No. 2023-238, this August Body determined that the said ordinance is a valid exercise of the legislative powers of their sanggunian and within the authority of MLGU San Manuel as prescribed by law subject to compliance with the budgetary limitations for debt servicing as provided in Section 324 of the Local Government Code;


**WHEREFORE**, upon motion of Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was –
