WHEREAS, Republic Act No. 11223, otherwise known as the “*Universal Health Care Act of 2019*”, mandates the DOH-Retained Hospitals in Region II to adopt the standardized curriculum set by the Philippine Academy of Family Physicians for the operation of a patient-centered, family focused, and community-oriented practice-based training program to produce practice-ready physicians adept in primary care;

WHEREAS, frontliner physicians, such as the City Health Officers, Municipal Health Officers and Medical Officers in Provincial and District Hospitals are required to be trained by the Department of Family and Community Medicine under a Practice-Based Residency Training Program. The training consists of off-site and online-based training in order to produce a competent and practice-ready physician in each and every LGU;

WHEREAS, as the main workforce of the government health care system, the Provincial Government of Isabela (PGI) is mandated to employ well-trained and competent Medical Officers. For further expansion of their knowledge and to acquire relevant training experiences, a Practice-Based Residency Training under the Department of Family and Community Medicine by LGUs Medical Officers are highly recommended;

WHEREAS, Southern Isabela Medical Center (SIMC), as a DOH-retained tertiary hospital and an accredited training hospital, has the capacity to provide the training of Medical Health Officers, City health Officers, Rural Health Physicians, and Medical Officers;

WHEREAS, the implementation of a Family and Community Medicine Practice-Based Residency Training Program and the deployment of Medical Officer III in the Southern Isabela Medical Center (SIMC), necessitates the execution of a Memorandum of Agreement with the latter;

WHEREAS, Section 465, (b) (vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
