**WHEREAS**, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers local government units to exercise all powers necessary or appropriate for the promotion and health and safety of its people;

**WHEREAS**, it is the policy of the Provincial Government of Isabela to provide its people with quality, effective, and affordable healthcare and medical services;

**WHEREAS**, in furtherance of such policy, the Provincial Government of Isabela acquired and maintains healthcare and medical facilities and equipment and have trained personnel and medical specialist that are fully capable of providing quality and effective healthcare and medical services;

**WHEREAS**, the City Government of Cauayan, Isabela is a component city duly created by law that is within the territorial jurisdiction of the Provincial Government of Isabela;

**WHEREAS**, the City Government of Cauayan, Isabela observes a policy similar to the Provincial Government of Isabela on the provision of quality, effective, and affordable healthcare and medical services to their people;

**WHEREAS**, the Provincial Government of Isabela and the City Government of Cauayan, Isabela aspires to deepen their collaboration on the extension of healthcare and medical services to their people through the establishment of medical resources sharing agreement and referral system;

**WHEREAS**, submitted for this review and approval of this August Body is the proposed Memorandum of Agreement to be entered into by the Provincial Government of Isabela and the City Government of Cauayan, Isabela for the establishment of a medical resources sharing agreement and referral system. Under such an agreement, the Provincial Government of Isabela shall make its health and medical equipment, facilities, and personnel under the Cauayan District Hospital, a hospital that it owns and operates, available to the people of the City Government of Cauayan, Isabela. Such an agreement covers the provision of ambulance service, clinical laboratory service, dental service, and radiologic service to the patients or constituents referred by the Rural Health Units and City Health Offices of the City Government of Cauayan, Isabela;

**WHEREAS**, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

**WHEREAS**, after careful review of such an agreement, this August Body finds the same to be just, lawful, and promotive of the health policies of the Provincial Government of Isabela hence it determined that granting the Provincial Governor the necessary authority to sign the same to be beneficial to the Isabeleños;

**WHEREFORE**, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
