**WHEREAS**, the Maconacon Rural Health Unit/Birthing Center has demonstrated its commitment to delivering excellent healthcare services to the residents of Maconacon Municipality;

**WHEREAS**, the Maconacon Rural Health Unit/Birthing Center seeks to partner with the PGI to implement a referral system that would enhance the healthcare network and improve access to specialized medical services;

**WHEREAS**, the proposed partnership and referral system would strengthen the collaboration between the PGI and the Maconacon Rural Health Unit/Birthing Center, ensuring efficient healthcare delivery and optimal patient care;

**WHEREAS**, submitted for the review and approval of this August Body is the draft Memorandum of Agreement to be executed between the PGI and Maconacon Rural Health Unit/Birthing Center which seeks to establish a partnership and patient referral system for the patients of Maconacon Rural Health Unit/Birthing Center;

**WHEREAS**, after a careful review of the Memorandum of Agreement this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

**WHEREAS**, Section 465 (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign on its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

**WHEREFORE**, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –


