**WHEREAS**, it is the policy of the Provincial Government of Isabela (PGI) to support and foster the development of the agriculture sector towards increased investments, infrastructure development, and improved access to markets and services to sustain the overall development and empowerment of rural communities;

**WHEREAS**, the Province of Isabela has identified and endorsed *Mungbean Seed Production and Marketing Enterprise*, an I-REAP subproject, as one of its priority

subproject under the Department of Agriculture's Philippine Rural Development Program (DA-PRDP), aimed at fostering agricultural development and promoting the welfare of local communities;

**WHEREAS**, the success and effective implementation of this I-REAP subproject requires the support and collaboration of Cabatuan Savings and Development Cooperative;

**WHEREAS**, consistent with the Enterprise Development Operations Manual and Procurement Guidelines of the DA-PRDP, the PGI procured articles to facilitate the implementation of the I-REAP subproject, particularly described as follows:

1. **One(1) Unit Vehicle (6 Tonner Truck);**
2. **One(1) Generator Set, 26KVA Kubota with Housing;**
3. **One(1) Unit Tractor (50hp) with rotavator and puddly sheel;**
4. **Four(4) Units Airconditioner tonner wall type;**
5. **Two(2) Units Humidity Tester (Center 337);**
6. **Fifty(50) Square Pallet 4 way 1200x1200mm;**
7. **One(1) Unit Center Car Motorcycle;**
8. **One(1) Unit Sorting Machine;**
9. **One(1) Unit Vacuum Sealer;**
10. **One(1) Unit Mobile Thresher-Husker-Sheller;**
11. **One(1) 25KVA Transformer, labor and material with pedestral; and**
12. **Mungbean warehouse with cold storage, Cabatuan Isabela**

**WHEREAS**, pursuant to Article V, Section 5.01(h) of the Enterprise Investment Agreement (EIA), the PGI through the Provincial Project Management and Implementing Unit (PPMIU) shall facilitate the turn-over of the prescribed articles through a Deed of Donation and Certificate of Turn-Over;

**WHEREAS**, submitted to this August Body is the proposed Deed of Donation executed between the PGI and Cabatuan Savings and Development Cooperative;

**WHEREAS**, after careful review of such deed, this August Body determined the same to be just, lawful, and promotive of the welfare of Isabeleños;

**WHEREAS**, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

**WHEREAS**, this August Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Deed of Donation on behalf of the Provincial Government of Isabela;

**WHEREFORE**, upon motion of the Honorable Adrian Philip S. Baysac, duly approved and seconded by all members in a session duly assembled, it was –
