**WHEREAS**, it is the policy of the Provincial Government of Isabela (PGI) to support and foster the development of the agriculture sector towards increased investments, infrastructure development, and improved access to markets and services to sustain the overall development and empowerment of rural communities;

**WHEREAS**, the Province of Isabela has identified and endorsed *Isabela Dairy Enterprise*, an I-REAP subproject, as one of its priority subproject under the Department of Agriculture's Philippine Rural Development Program (DA-PRDP), aimed at fostering agricultural development and promoting the welfare of local communities;

**WHEREAS**, the success and effective implementation of this I-REAP subproject requires the support and collaboration of Mallig Dairy Multipurpose Cooperative;

**WHEREAS**, consistent with the Enterprise Development Operations Manual and Procurement Guidelines of the DA-PRDP, the PGI procured articles to facilitate the implementation of the I-REAP subproject, particularly described as follows:

1. **One(1) Unit Generator Set, mdl. SDE80CS3 80KVA, 240V, 60Hz 3 phase with Automatic transfer switch sound proof;**
2. **One(1) Unit Steam Boiler 40 Bhp;**
3. **One(1) Unit Water Softener/Purifier, Package 4, supply of labor materials, installation for one(1) unit, 3 stages;**
4. **One(1) Unit Cabinet Type chiller, 20 cuft.220v, single phase;**
5. **Eight(8) Units Insulated Coolers, 70 quarts cooler, holds 100 cans (113.41kgs) hinged lid support up to 250 lbs.;**
6. **Five(5) Units Milk Cans, 40ltrs capacity, stainless steel # 3162, tool grade, clip type;**
7. **One(1) Unit Ice Bank;**
8. **One(1) Unit Batch Pasteurizer;**
9. **One(1) Unit Homogenizer;**
10. **One(1) Holding Tank with Stirrer;**
11. **One(1) Unit Receiving vat with Agitator;**
12. **One(1) Unit Sanitary Pipe, fitting with Milk Pump;**
13. **One(1) Unit Electric Control-for all equipment;**
14. **One(1) Unit Cold Storage; and**
15. **One(1) Unit Dairy Processing Plant**

**WHEREAS**, pursuant to Article V, Section 5.01(h) of the Enterprise Investment Agreement (EIA), the PGI through the Provincial Project Management and Implementing Unit (PPMIU) shall facilitate the turn-over of the prescribed articles through a Deed of Donation and Certificate of Turn-Over;

**WHEREAS**, submitted to this August Body is the proposed Deed of Donation executed between the PGI and Mallig Dairy Multipurpose Cooperative;

**WHEREAS**, after careful review of such deed, this August Body determined the same to be just, lawful, and promotive of the welfare of Isabeleños;

**WHEREAS**, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;
