**WHEREAS**, the Provincial Government of Isabela recognizes its indigenous peoples as a vital part of its inclusive development goals. As such, it established mechanisms that aim to bring genuine prosperity to their communities with due consideration to their culture, customs, and traditions;

**WHEREAS**, the Provincial Government of Isabela recognizes that education, through the learning of knowledge and skills, raises the competitiveness and productivity of its people and hence recognizes education as an impactful driver for socio-economic growth;

**WHEREAS**, this August Body acknowledges that the socio-economic empowerment of its indigenous peoples, through education, will advance the inclusive development goals of the Provincial Government of Isabela;
