**WHEREAS**, the Provincial Government of Isabela is an active advocate of volunteerism. It has consistently served as a pacesetter in extending helpful aid and assistance to local government units that are experiencing challenges caused by natural disasters;

**WHEREAS**, the Province of Albay is currently experiencing difficulties as the Mayon Volcano has been spewing ash and lava and producing volcanic tremors and rockfalls in the past weeks which have prompted tens of thousands of Albayanos to evacuate;

**WHEREAS**, with the Mayon Volcano continuing to show signs of unrest, the Philippine Institute of Volcanology and Seismology, through their Chief, Dr. Teresito Bacolcol, has not ruled out the possibility of a hazardous and explosive eruption;

**WHEREAS**, in view of the dire conditions in Albay, the entirety of the Provincial Government of Isabela hereby acknowledges that there exists an urgent need to extend aid and assistance to the Albayanos;

**WHEREAS**, the Office of the Vice Governor of the Province of Isabela, in line with the spirit of *Bayanihan*, hereby declares its commitment to extend monetary assistance to the Provincial Government of Albay;

**WHEREAS**, the people of Isabela are one with the people of Albay in facing the challenges caused by the Mayon Volcano's unrest and the Provincial Government of Isabela undertakes to work closely with the Provincial Government of Albay for the improvement of conditions in their area;

**WHEREFORE**, upon motion of the Honorable Victor G. Dy, duly approved and seconded in a session duly assembled, it was –
