**WHEREAS**, Republic Act No. 11494, or the Bayanihan as One Act, was enacted to address the difficulties brought about by the COVID-19 pandemic and to fast-track the country's economic recovery; //

**WHEREAS**, among the many goals of the Bayanihan as One Act was to "alleviate the economic cost and losses stemming from the pandemic and enhance the country's financial stability to support government programs in combatting COVID-19";

**WHEREAS**, in line with the goals of the Bayanihan as One Act, the National Government appropriated One Billion Pesos (Php1,000,000,000.00) each to the Development Bank of the Philippines and the Land Bank of the Philippines to subsidize the payment on interest on new and existing loans secured by local government units;

**WHEREAS**, pursuant to the directive of the National Government, the Development Bank of the Philippines developed the ASENSO-Interest Subsidy Fund (ISF) Program. The main feature of this program is the interest subsidy offered to the LGUs for their new and existing loans to provide a form of relief from the financial constraints that the LGUs were facing;

**WHEREAS**, the Provincial Government of Isabela was among those LGUs which were recognized as eligible to benefit, and thereafter was granted benefits, under the ASENSO-ISF Program;

**WHEREAS**, in view of such eligibility and grant, the interest of the PGI's loans with the DBP in the amount of Php100,162,918.33 was subsidized;

**WHEREAS**, the PGI aspires to utilize such amount to fund its medical-, educational-, and agriculture-related PPAs;

**WHEREAS**, submitted for the review and consideration of this August Body is Provincial Development Council Resolution No. 05, series of 2023 endorsing for adoption and approval the Supplemental Annual Investment Program of the Provincial Government of Isabela for FY 2023 which outlines the programs, projects, and activities that will be funded by the monetary benefits granted by the Development Bank of the Philippines under their ASENSO-Bayanihan ISF;

**WHEREAS**, as provided in the said Supplemental Annual Investment Plan, the PGI aspires to utilize such monetary benefit as follows:
