**WHEREAS**, Appropriation Ordinance No. 08 Series of 2023, an Ordinance authorizing Supplemental Budget No. 06 FY 2023 of the Local Government Unit of Quirino, Isabela amounting to **ONE MILLION SEVEN HUNDRED THIRTY ONE THOUSAND TWO HUNDRED FORTY SIX PESOS & 86/100 (P1,731,246.86)** for Personal Services (Implementation of SSL V – Fourth Tranche) of the Municipality of Quirino, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

**NOW THEREFORE**, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

**THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:**

**RESOLVED**, to declare Appropriation Ordinance No. 08 S. 2023 of the Municipality of Quirino, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The appropriation for the implementation of SSL V Compensation Adjustment – 4th Tranche in the amount of One Million Seven Hundred Thirty One Thousand Two Hundred Forty Six Pesos & 86/100 (P1,731,246.86) must be in accordance with the guidelines of DBM Local Budget Circular No. 149, dated January 10, 2023, on the Implementation of the Fourth Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to Republic Act (RA) No. 11466;
2. Reiterating our review on your Annual Budget 2020, 2021, 2022 & 2023 that the position of Dentist II with SG-17/8 *when becomes vacant shall be downgraded to Dentist I SG-14/1* to conform with the provisions of Item 9.2.1.5 of the Manual on the Position Classification and Compensation Scheme (MPCCS) in LGUs under Circular Letter No. 2007-6 dated February 19, 2007 *which the highest level of Positions below the Assistant Department Head shall be limited to the allocated Salary Grade for fourth to sixth class municipalities which is Salary Grade 14-16.*
3. That the appropriation for the following account should be properly classified to specific Object of Expenditures and Account Code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:
