A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 2023 - 03 (SUPPLEMENTAL BUDGET NO. 03 FY 2023) IN THE AMOUNT OF ONE MILLION NINE HUNDRED SEVENTY SEVEN THOUSAND EIGHT HUNDRED SIXTY SEVEN PESOS (P1,977,867.00) OF THE MUNICIPALITY OF BENITO SOLIVEN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

WHEREAS, Appropriation Ordinance No. 2023-03, an Ordinance authorizing Supplemental Budget No. 03 S. 2023 of the Municipality of Benito Soliven, Isabela involving the amount of **ONE MILLION NINE HUNDRED SEVENTY SEVEN THOUSAND EIGHT HUNDRED SIXTY SEVEN PESOS (P1,977,867.00)** derived from Share of the Municipality of Benito Soliven, Isabela on the collection of Burley and Native Tobacco Excise Taxes for Calendar Year 2020, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2023-03 of the Municipality of Benito Soliven, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160 and subject to further conditions:

1. The utilization of the project to be funded from the Local Government share in the Burley and Native Tobacco Excise Tax for the Fiscal Year 2020 amounting to One Million Nine Hundred Seventy Seven Thousand Eight Hundred Sixty Seven (P1,977,867.00), shall adhere with the provisions of LBM No. 86, dated December 14, 2022, the Guidelines on the release and utilization of the shares of Local Government Units (LGUs) from the FY 2020 collections of Excise Taxes on Locally Manufactured Virginia-type Cigarettes under Republic Act No. 7171, and Burley and Native Tobacco Excise Taxes pursuant to RA No. 8240, as amended by RA No. 10351, and as further amended by RA No. 11346, chargeable against the Allocations to Local Government Units (ALGU) under the FY 2022 General Appropriations Act (GAA), RA No. 11639;
2. The appropriation for Donations under the Office of the Municipal Agriculturist in the amount of Six Hundred Ninety Thousand Pesos (P690,00.00) shall be classified according to its specific Programs, Projects & Activities (PPAs);
3. The project **Provision of 1 unit Brand New Four Row Mechanical Corn Seeder** is not included in the menu/projects to be funded from the LGU share from Burley and Native Tobacco Excise Tax (LBM No. 86). However, said project shall be replaced or substituted with another project that is compliant with **Item No. 2.3.1 of LBM No. 86**;
4. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of Benito Soliven, Isabela to comply with the herein conditions.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable ROBERTO T. LUNGAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Benito Soliven, Isabela, through the **Honorable JOHN PAUL S. AZUR**, Municipal Vice-Mayor.
