**WHEREAS**, Ordinance No. 2023-05, an Ordinance authorizing Supplemental Budget No. 01 S. 2023 of the Municipality of Cabatuan, Isabela involving the amount of **TEN MILLION FIVE HUNDRED FORTY FOUR THOUSAND NINE HUNDRED SIXTY PESOS AND 62/100 (P10,544,960.62)** derived from Savings from Programmed Appropriations of CY 2022, Actual Collections in Excess of Estimated Income, and Proceeds of Sale of Unserviceable Motor Vehicle of the Local Government of Cabatuan, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

**NOW THEREFORE**, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

**THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:**

**RESOLVED**, to declare Appropriation Ordinance No. 2023-05 of the Municipality of Cabatuan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. The utilization of Terminal Leave Benefits in the amount of One Million Forty Five Thousand Three Hundred Seventy Pesos (P1,045,370.00) shall be in accordance with DBM Budget Circular No. 2016-2 dated March 29, 2016 on the Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits , and CSC Memorandum Circular No. 02 s. 2016, on Amendment to the Constant Factor in the Formula Used for Computing Terminal Leave Benefits (Section 40) and Computation of Leave Monetization (Section 24) of the Omnibus Rules on Leave;
2. The appropriation for the following account should be properly classified to specific Object of Expenditures and Account Code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:

3. Specify appropriate Object of Expenditure of Other Supplies and Materials Expense for the Fund for the Crops, Livestock, and Fishery Programs of DA in the amount of Four Hundred Fifty Thousand Pesos (P450,000.00);
4. The appropriation for Donations under the Municipal Social Welfare and Development Office in the amount of Seven Hundred Thousand Pesos (P700,00.00) shall be classified according to its specific Programs, Projects & Activities (PPAs);
5. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations. Further, the acquisition of Motor Vehicles in the amount of Four Million Five Hundred Thousand Pesos (P4,500,000.00) shall be subject to the provisions of Budget Circular No. 2022-1 dated February 11, 2022, the Omnibus Guidelines on the Acquisition, Use, Rental and Replacement of Government Motor Vehicles.

**RESOLVED FURTHER**, to require the Municipality of Cabatuan, Isabela to comply with the herein conditions.

**RESOLVED FURTHER**, to inform the Municipality of Cabatuan, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable BERNARDO A. GARCIA, JR.**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Cabatuan, Isabela, through the **Honorable CHARLTON L. UY**, Municipal Vice-Mayor.
