WHEREAS, on November 10, 2023, the Provincial Disaster Risk Reduction and Management Council of the Province of Isabela convened and issued Resolution No. 01, series of 2023. This resolution approved the reprogramming of funds within the Local Disaster Risk Reduction and Management Fund of the Provincial Government of Isabela for Fiscal Year 2023 amounting to Twenty Nine Million Pesos (Php29,000,000.00) to fund the implementation of the Project/Program/Activity (PPA) "Other PPE- Disaster Equipment";

WHEREAS, as approved by the Provincial Disaster Risk Reduction and Management Council of the Province of Isabela, the funds for such reprogramming shall be sourced from the following accounts under the Local Risk Reduction and Management Funds of the Provincial Government of Isabela for Fiscal Year 2023:
