A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 13, SERIES OF 2023 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF REINA MERCEDES, ISABELA AS INTRA VIRES

WHEREAS, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to "review all ordinances approved by the sanggunian of component cities and municipalities" and to "determine whether these are within the scope of the prescribed powers of the sanggunian";

WHEREAS, presented before this Honorable Body is Municipal Ordinance No. 13 Series of 2023 of the Municipal Local Government Unit of Reina Mercedes, Isabela (MLGU Reina Mercedes) titled "**AN ORDINANCE CONFIRMING AND RATIFYING THE TERM AND CONDITION OF LOAN AGREEMENT EXECUTED BY AND BETWEEN THE LGU-REINA MERCEDES AND THE LANDBANK OF THE PHILIPPINES AND APPROPRIATING FUNDS THEREOF**";

A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 13, SERIES OF 2023 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF REINA MERCEDES, ISABELA AS INTRA VIRES

WHEREAS, as stated in the Ordinance, MLGU Reina Mercedes will enter into a Loan Agreement with the Land Bank of the Philippines for the amount of Forty-Three Million Pesos (Php43,000,000.00) to finance various projects provided as follows:

1. Purchase of Lot
2. Procurement of Furniture for New Municipal Building
3. Supply and Installation of Air-conditioning Units at New Municipal Building
4. Supply and Installation of Electro-Mechanical Works at New Municipal Building

WHEREAS, section 297(a) of the Local Government Code allows local government units to contract loans, credits, and other forms of indebtedness with any government or domestic private bank and other lending institutions to finance the construction, installation, improvement, expansion, operation, or maintenance of public facilities, infrastructure facilities and the implementation of other capital investment projects, subject to such terms and conditions as may be agreed upon by the local government unit and the lender;

WHEREAS, this Honorable Body recognizes that local government units possess direct information concerning the needs of their citizens and the conditions within their jurisdiction and thus have the appropriate standing and capacity to identify the programs, projects, and activities that will further the welfare of their people;

WHEREAS, after careful review and with due consideration to the recommendation of the Provincial Budget Office interposing no objection and stating no adverse finding to the Ordinance No. 13, Series of 2023 of the MLGU Reina Mercedes, this Honorable Body find that the said ordinance is a valid exercise of the legislative powers of their sanggunian and within the authority of MLGU Reina Mercedes as prescribed by law subject to compliance with the budgetary limitations for debt servicing as provided in Section 324 of the Local Government Code;

WHEREFORE, upon motion of the Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 13, SERIES OF 2023 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF REINA MERCEDES, ISABELA AS INTRA VIRES.


