WHEREAS, payment of Real Property Taxes are essential to sustain and enhance local government operations, enabling Local Government Units (LGUs) to respond effectively to the evolving needs and aspirations of the community;

WHEREAS, in accordance with the provisions of Section 254 of Republic Act No. 7160, otherwise known as The Local Government Code of 1991, a notice from the Office of the Provincial Treasurer of Isabela has been served to notify the public that the Real Property tax dues for the calendar year 2023 and previous years have become delinquent;

A RESOLUTION ENCOURAGING ISABELEÑOS TO TIMELY AND RESPONSIBLY SETTLE THEIR REAL PROPERTY TAX OBLIGATIONS FOR THE ADVANCEMENT OF LOCAL DEVELOPMENT AND COMMUNITY WELFARE

WHEREAS, under the said Code, LGUs are charged with the duty to enforce the collection of delinquent taxes, and the LGU concerned may avail of the remedies by administrative action or judicial action, including but not limited to seizure of personal property, filing civil suits, and levying on real property for public auction;

WHEREAS, failure to pay the real property tax within the stipulated period shall subject the taxpayer to the payment of interest at the rate of (2%) per month on the unpaid amount or a fraction thereof;

WHEREAS, unless the tax, surcharges, and penalties are paid before the expiration of the year for which the taxes are due, delinquent real properties will be sold at public auction, with the title vested in the purchaser, subject to the right of the delinquent owner or any person having legal interest therein to redeem the property within one (1) year from the date of sale;

WHEREAS, delinquent taxpayers may be freed from legal actions imposed by law by settling the delinquent tax or installment thereof, along with the corresponding penalty, as provided under the Code;

WHEREAS, the success of Real Property Tax collection efforts relies on the voluntary cooperation of property owners, and the Province of Isabela recognizes the importance of fostering a sense of ownership and commitment to the well-being of the community;

WHEREAS, the Province of Isabela encourages taxpayers to actively participate in the development and growth of their communities by fulfilling their civic responsibility of timely and responsible payment of Real Property Taxes;

NOW THEREFORE, upon motion of the Honorable Clifford R. Raspado, duly approved and seconded in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION ENCOURAGING ISABELEÑOS TO TIMELY AND RESPONSIBLY SETTLE THEIR REAL PROPERTY TAX OBLIGATIONS FOR THE ADVANCEMENT OF LOCAL DEVELOPMENT AND COMMUNITY WELFARE.
