WHEREAS, local government units are duly empowered to create their own sources of revenue subject to limitations prescribed by law;

WHEREAS, to optimize the use and maximize the value of some of its properties and facilities, the Provincial Government of Isabela enters into pecuniary contracts with individuals and institutions for the lease thereof which are renewable every year;

WHEREAS, such contracts have lapsed last December 31, 2023;

WHEREAS, the lessees of such properties and facilities have signified their intention to renew their lease agreements with the Provincial Government of Isabela;

WHEREAS, this Honorable Body acknowledges the fact that such agreements provide the Provincial Government of Isabela with much-needed revenues which are then utilized to fund its programs, projects, and activities for Isabeleños, and that the lessees obtain viable economic opportunities therefrom due to the commercially-active locations of such properties and facilities;

WHEREAS, Section 465, par. (b) (1) (vi) of the Local Government Code empowers the Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, upon motion of Honorable Clifford R. Raspado, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA ALL CONTRACTS PERTAINING TO THE LEASE OF ITS PROPERTIES AND FACILITIES THAT ARE DUE FOR RENEWAL FOR CALENDAR YEAR 2024.
