WHEREAS, the SSF is envisioned to play a vital role in the development of priority and market-driven industries within the Province of Isabela, thereby contributing to economic growth and sustainability;

WHEREAS, the implementation of the Rattan Processing SSF project necessitates the execution of a Deed of Donation between the Provincial Government of Isabela (PGI) and the Department of Trade and Industry (DTI) for the transfer of the following Rattan Processing SSF machines, tools, and equipment owned by the DTI, as specified below:

- 10 units of Rattan Pole Rack w/ Trolley
- 8 sets of Air Compressor with Hose and Fittings Sets with Bundles Accessories
- 10 units of Compound Miter Saw Heavy Duty
- 10 units of Treatment Vat
- 5 units of Wood Lathe Machine
- 3 units of Rattan Straightening Machine with Air Compressor
- 10 units of Rattan Pole Cutter
- 10 units of Rattan Splitter Sizer
- 4 units of Sanding Machine for Rattan
- 10 units of Cordless Portable Electric Drill
- 10 units of Electric Drill Press with Drill Bits Set, Wood Hole Saw set not included
- 10 units of Rattan Pole Bending Jigs, Fabricated
- 10 units of Wooden Table
- 10 units of Arc Welding Machine
- 4 sets of Combination Bar and Pipe Cutter
- 5 units of Industrial Bench Vise Heavy Duty
- 12 units of Thickness Planer Heavy Duty
- 5 units of Band Saw Heavy Duty
- 10 units of Industrial Sewing Machine Heavy Duty
- 10 units of Leather Stitching Sewing Machine Heavy Duty
- 1 set Industrial Electric Water Pump with Tank Accessories
- 10 units of Woodwork Precision Joint Planer
- 8 units of Woodwork Router Machine

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;


NOW THEREFORE, upon motion of the Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was –
