**A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, A MEMORANDUM OF AGREEMENT FOR THE RENEWAL OF THE CREDIT LINE OF GOVERNOR FAUSTINO N. DY SR. MEMORIAL HOSPITAL WITH THE OFFICE OF THE VICE PRESIDENT**

**WHEREAS**, the Office of the Vice President (OVP) recognizes the importance of strengthening its medical assistance program to better serve the needs of the public;

**WHEREAS**, the OVP aims to enhance its service delivery network by renewing the agreement with the Provincial Government of Isabela (PGI) entered into in 2023;

**WHEREAS**, the OVP intends to establish a credit line with the PGI, not exceeding Five Hundred Thousand Pesos (P500,000.00), specifically allocated for medical assistance to the eligible clients of the Governor Faustino N. Dy Sr. Memorial Hospital, through the issuance of guarantee letters by the OVP;

**WHEREAS**, the OVP seeks collaboration with the PGI to achieve this goal, and both parties are willing to formalize their commitment through a Memorandum of Agreement, setting forth the terms and conditions governing their collaboration;

**WHEREAS**, submitted for the review and approval of this August Body is the proposed Memorandum of Agreement to be entered into by the PGI;

**WHEREAS**, after careful review, this August Body determined that the proposed MOA for the renewal of the credit line of Governor Faustino N. Dy Sr. Memorial Hospital with the OVP to be just and lawful, and that granting the Provincial Governor the authority to sign the same on behalf of the Provincial Government of Isabela is deemed beneficial to the well-being of the Isabeleños;

**WHEREAS**, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

**WHEREFORE**, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was -

**RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, A MEMORANDUM OF AGREEMENT FOR THE RENEWAL OF THE CREDIT LINE OF GOVERNOR FAUSTINO N. DY SR.
