**WHEREAS**, the DOH-CVCHD endeavors that the Medical Assistance to Indigents and Financially Incapacitated Patients Program be made available in the province of Isabela. Towards this end, it proposed the execution of a Memorandum of Agreement with the Provincial Government of Isabela for the implementation of the said program in the Governor Faustino N. Dy Sr. Memorial Hospital;

**WHEREAS**, submitted for the review and approval of this August Body is the proposed Memorandum of Agreement between the Provincial Government of Isabela and DOH-CVCHD for the implementation of the Medical Assistance to Indigents and Financially Incapacitated Patients Program in Governor Faustino N. Dy Sr. Memorial Hospital;

**WHEREAS**, after careful review, this August Body determined that the proposed Memorandum of Agreement between the Provincial Government of Isabela and DOH-CVCHD is just and lawful, and advances the policy of the Provincial Government of Isabela to provide its people with ready access to affordable and efficacious medical and healthcare services;

**WHEREAS**, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

**WHEREFORE**, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was -
