WHEREAS, the Memorandum of Agreement between PGI and DA-PCC signifies its commitment to fostering partnerships that contribute to the overall development of the agricultural sector within the province;

WHEREAS, submitted for the review and approval of this August Body is a Memorandum of Agreement (MOA) to be entered into by and between the Provincial Government of Isabela and Isabela Aquaculture Cooperative for the undertaking discussed in the previous whereas clause:
