2. Enrollment for BIR & PHILHEALTH for Electronic Payment
Maker: Provincial Accounting Office
Authorizer: Provincial Treasurer & Provincial Administrator
3. Institutionalize Payroll Services;
User: Provincial Accounting Office
Authorizer: Provincial Treasurer & Provincial Administrator

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after a careful review of the said Banking Solutions, along with its accompanying documents, this Body deems it beneficial and advantageous for the Province to grant the Governor, Honorable Rodolfo T. Albano III, the necessary authority to enroll and avail of the aforementioned Banking Solutions with the Land Bank of the Philippines, Ilagan Branch;
