**WHEREAS**, Republic Act No. 6975, otherwise known as, "An Act Establishing the Philippine National Police under a Reorganized department of the Interior and Local Government, and for other Purposes" was enacted creating the Philippine Public Safety College (PPSC) which shall be the premier educational institution for the training, human resource development, and continuing education of all personnel of the PNP, Fire, and Jail Bureaus;

**WHEREAS**, the PPSC was composed of the Philippine National Police Academy (PNPA), the Fire Service Training Center, the Philippine National Training Center (PNTC), the National Police College, and other special training centers as may be created by the Department of Interior and Local Government (DILG);

**WHEREAS**, considering the immense contribution and unwavering support of the late Governor for the construction of buildings in RTC 2, the City Government of Cauayan, Isabela, thru Resolution No. 2023-154, has manifested its support to rename the present Regional Training Center (RTC-2) to Regional Training Center 2 Camp Faustino N. Dy Sr.;

**WHEREAS**, this August Body finds no reason to convey an adverse statement to their submitted resolution and further expresses its support to the same;
