WHEREAS, it is the policy of the Provincial Government of Isabela (PGI) to continuously improve and upgrade the services and facilities of its public healthcare institutions, exemplified by the recent acquisition of new CT Scan Machines by the Governor Faustino N. Dy, Sr. Memorial Hospital (GFNDSMH);

WHEREAS, the procurement of new CT Scan Machines has created a demand for additional CT-SCAN Reader/Radiologists to efficiently handle the expected influx of patients availing of this service;

WHEREAS, Dr. Paula Marie S. Inocencio, Dr. Krystle Anne D. Blaso, Dr. Maria Martha Josefa R. Manuel, and Dr. Danlen C. Masangya, all accredited radiologists, have expressed their commitment to providing their services for the required positions to manage the increased workload;

WHEREAS, after a careful review of the said MOA, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREFORE, premises considered, upon motion of the Honorable Edward S. Isidro, duly approved and seconded in a session duly assembled, it was –
