A RESOLUTION APPROVING THE PROVINCIAL DEVELOPMENT COUNCIL RESOLUTION NO. 07, SERIES OF 2023, THEREBY ADOPTING THE ENHANCED PROVINCIAL COMMODITY INVESTMENT PLAN OF THE PROVINCIAL GOVERNMENT OF ISABELA FOR THE YEARS 2024 TO 2026

WHEREAS, the Provincial Government of Isabela actively upholds its policy on extending preferential consideration to the welfare of the local farmers and the development of the local agriculture sector in the formulation of its policies, development of its plans, and the implementation of its programs and projects;

WHEREAS, in line with this policy, the Provincial Government of Isabela has partnered with the Department of Agriculture (DA) for the implementation of the Philippine Rural Development Project (PRDP) in the province of Isabela;

WHEREAS, the implementation of the PRDP in the province has resulted in the improvement of the local agri-fishery sector which has provided a reliable and sustainable source of income and livelihood to countless Isabeleños;

WHEREAS, the Provincial Government of Isabela and the DA recognizes that new components to the PRDP can be introduced to further improve its effectivity and further expand its reach, notably risk and climate resilience strategies and the new PRDP Scale-up;

WHEREAS, recognizing the need to incorporate newly developed interventions and reforms from the PRDP into the plans of the Provincial Government of Isabela, there exists a need to update the Provincial Commodity Investment Plan;

WHEREAS, the Provincial Commodity Investment Plan plays a significant role in improving the economic and social conditions of rural farmers through the implementation of interventions. It is a critical tool used by the provincial government to address the challenges encountered by farmers by providing them with infrastructure, enterprise, and technical support;

WHEREAS, the Provincial Development Council (PDC) is the primary policy recommending body in the Provincial Government of Isabela tasked with preparation of plans, including the Provincial Commodity Investment Plan, which are aimed at addressing macro-scale concerns in Isabela and advancing the welfare of the Isabeleños;

WHEREAS, the PDC, through the Provincial Project Management and Implementing Unit (PPMIU) Planning at the Local and National Level (IPLAN) Component, has convened with the DA, other National Government Agencies, and stakeholders for the preparation of the Enhanced Provincial Commodity Investment Plan of the Provincial Government of Isabela which will integrate therein the reforms in the PRDP and newly developed approaches for the development of the agri-fishery sector;

WHEREAS, presented before this August Body is PDC Resolution No. 07, series of 2023 which approved and adopted the Enhanced Provincial Commodity Investment Plan of the Provincial Government of Isabela for the year 2024 to 2026, as prepared, formulated, and approved by the PDC, the DA, National Government Agencies, and stakeholders;

WHEREAS, after an extensive review of the submitted Enhanced Provincial Commodity Investment Plan, this August Body found that such included the results of value chain analyses (VCA) of dairy, mungbean, tilapia, aromatic and pigmented rice, pineapple, mango, white corn, beef, cattle, and banana. Also, it integrated risk and climate resilience strategies and effective approaches from the PRDU SU IPLAN Enhanced Operations Manual. Furthermore, it determined that such is consistent with the Agriculture Fishery Modernization and Industrialization Plan, and the IPLAN;

WHEREAS, considering the foregoing, this August Body hereby approves and the submitted Enhanced Provincial Commodity Investment Plan of the Provincial Government of Isabela for the years 2024 to 2026, as submitted by the PDC;
