A RESOLUTION DECLARING ORDINANCE NO. 2023-357 (SUPPLEMENTAL BUDGET NO. 01 FY 2023) IN THE AMOUNT OF SEVENTEEN MILLION NINE HUNDRED FORTY TWO THOUSAND TWO HUNDRED NINETY TWO PESOS AND 40/100 (P17,942,292.40) OF THE MUNICIPALITY OF ANGADANAN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

WHEREAS, Ordinance No. 2023-357, an Ordinance authorizing Supplemental Budget No. 01, S. 2023 of the Municipality of Angadanan, Isabela involving an amount **SEVENTEEN MILLION NINE HUNDRED FORTY TWO THOUSAND TWO HUNDRED NINETY TWO PESOS AND 40/100 (P17,942,292.40)** from Savings from CY 2022 to cover requirement for the grant of Service Recognition Incentives (SRI) and other expenditures of the Municipal Government of Angadanan, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member LOURDES S. PANGANIBAN** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2023-357 of the Municipality of Angadanan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The appropriation for Overtime and Night Pay in the amount of One Hundred Thousand Pesos (P100,000.00) shall be in accordance with the guidelines of CSC-DBM Joint Circular No. 2, series 2015 dated November 25, 2015, on the Policies and Guidelines on Overtime Services and Overtime Pay for Government Employees;
2. The utilization of Terminal Leave Benefits in the amount of Two Million Eighty Thousand Three Hundred Eighty and 36/100 pesos (P2,080,380.36) shall be in accordance with DBM Budget Circular No. 2016-2 dated March 29, 2016, on the Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, and CSC Memorandum Circular No. 02, s. 2016, on Amendment to the Constant Factor in the Formula used for Computing Terminal Leave Benefits (Section 40) and Computation of Leave Monetization (Section 24) of the Omnibus Rules on Leave;
3. The appropriation for the grant of Service Recognition Incentive (SRI) in the amount of Two Million One Hundred Twenty Thousand (P2,120,000.00) shall be in accordance with DBM Budget Circular No. 2023-2, dated December 13, 2023, on the Guidelines on the Grant of Service Recognition Incentive to Government Employees for Fiscal Year (FY) 2023;
4. The appropriation for **Donations** under the Office of the Municipal Social Welfare and Development office in the amount of five hundred thousand pesos (P500,000.00) shall be classified according to its specific Programs, Projects & Activities (PPAs);
5. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations. Further, the acquisition of Motor Vehicles in the amount of five million seven hundred thousand pesos (P5,700,000.00) shall be subject to the provisions of Budget

RESOLVED FURTHERMORE, to inform the Municipality of Angadanan, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
