A RESOLUTION DECLARING ORDINANCE NO. 2023-035 (SUPPLEMENTAL BUDGET NO. 07 FY 2023) IN THE AMOUNT OF TEN MILLION FIVE HUNDRED THIRTEEN THOUSAND PESOS (P10,513,000.00) OF THE MUNICIPALITY OF JONES, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Ordinance No. 2023-035, an Ordinance authorizing Supplemental Budget No. 07 S. 2023 of the Municipality of Jones, Isabela involving the amount of **TEN MILLION FIVE HUNDRED THIRTEEN THOUSAND PESOS (P10,513,000.00)** for the grant of Service Recognition Incentive to employees and Gratuity Pay to JO/COS workers and various PPAs of the Local Government of Jones, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member LOURDES S. PANGANIBAN** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2023-035 of the Municipality of Jones, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. The appropriation for the grant of Service Recognition Incentive (SRI) in the amount of Four Million Eight Hundred Thousand Pesos (P4,800,000.00) shall be in accordance with Administrative Order No. 12 dated December 7, 2023 and DBM Budget Circular No. 2023-2, dated December 13, 2023, on the Guidelines on the Grant of Service Recognition Incentive to Government Employees for FY 2023;
2. The grant of Gratuity Pay to Contract of Service and Job Order Workers of LGU- Jones, Isabela in the amount of Two Million Four Hundred Seventy Five Thousand Pesos (P2,475,000.00) shall be in accordance with Administrative Order No. 13 dated December 7, 2023 and DBM Budget Circular No. 2023-3 dated December 13, 2023, on the Guidelines on the Grant of the Gratuity Pay to Contract of Service (COS) and Job Order (JO) Workers in Government for FY 2023;
3. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

RESOLVED FURTHER, to inform the Municipality of Jones, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.


