**WHEREAS**, Appropriation Ordinance No. 19 Series of 2023, an Ordinance authorizing Supplemental Budget No. 10 FY 2023 of the Local Government Unit of Quirino, Isabela amounting to **TWO MILLION FIVE HUNDRED SIXTEEN THOUSAND SIX HUNDRED SIXTEEN PESOS & 31/100 (P2,516,616.31)** derived from PS savings from May 1 to October 31, 2023 to be used for Terminal Leave Benefits and for the grant of Performance Based Bonus (PBB) for FY 2022 to officials and employees of the Municipality of Quirino, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 19 S. 2023 of the Municipality of Quirino, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following condition:

1. The grant of Performance Based Bonus (PBB) in the amount of Two Million Eighty Eight Thousand Four Hundred Seventy Two Pesos & 31/100 (P2,088,472.31) shall be in accordance with IATF on the Harmonization of National Government Performance Monitoring, Information and Reporting Systems Memorandum Circular No. 2022-1, dated March 24, 2022, on the Guidelines on the Grant of the Performance-Based Bonus (PBB) for Fiscal Year 2022 under Executive Order No. 80, s., 2012 and Executive Order No. 201, s. 2016 and DILG-DBM Joint Memorandum Circular No. 2021-01, dated November 22, 2021 as amended by DILG-DBM Joint Memorandum Circular No. 2023-01, dated August 4, 2023;
2. The grant of Terminal Leave Benefits in the amount of Four Hundred Twenty Eight Thousand One Hundred Forty Four Pesos (P428,144.00), shall be in accordance with CSC Omnibus Rules on Leave pursuant to CSC Memorandum Circular No. 41, s. 1998, BC No. 2013-1 dated April 12, 2013, BC No. 2016-2 dated March 29, 2016 and CSC Memorandum Circular No. 02, s. 2016;

**RESOLVED FURTHER**, to require the Municipality of Quirino, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

**RESOLVED FURTHERMORE**, to inform the Municipality of Quirino Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
