**RESOLVED**, to declare Appropriation Ordinance No. 024-2023 (Supplemental Budget No. 4 FY 2023) of the Municipality of Delfin Albano, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The appropriation for the grant of Other Personnel Benefits - Service Recognition Incentive (SRI) in the amount of Two Million Ninety Eight Thousand Five Hundred Pesos (P2,098,500.00) shall be in accordance with Administrative Order No. 12 by the President of the Philippines, dated December 7, 2023, Authorizing the Grant of Service Recognition Incentive to Government Employees for Fiscal Year 2023 and DBM Budget Circular No. 2023-2, dated December 13, 2023 on the Guidelines on the Grant of Service Recognition Incentive to Government Employees for FY 2023;

**RESOLVED FURTHER**, to require the Municipality of Delfin Albano, Isabela to comply with the herein review findings/conditions.

**RESOLVED FURTHERMORE**, to inform the Municipality of Delfin Albano, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
