A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2023-20 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF JONES, ISABELA AS INTRA VIRES

WHEREAS, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to “review all ordinances approved by the sanggunian of component cities and municipalities” and to “determine whether these are within the scope of the prescribed powers of the sanggunian”;

WHEREAS, presented before this Honorable Body is Municipal Ordinance No. 2023-34 of the Municipal Local Government Unit of Jones, Isabela (MLGU Jones) titled “**AN ORDINANCE APPROVING THE TERMS AND CONDITIONS OF THE LOAN FROM THE LANDBANK OF THE PHILIPPINES – SOUTHERN ISABELA LENDING CENTER, CAUAYAN CITY AND AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE NHEL C. MONTANO, CPA, JONES, ISABELA TO EXECUTE AND DELIVER ANY AND ALL PROMISSORY NOTES,**

A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2023-20 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF JONES, ISABELA AS INTRA VIRES

DEED OF ASSIGNMENTS AND OTHER NECESSARY DOCUMENTS AND PROVIDING OTHER NECESSARY SPECIFICS THEREOF”;

WHEREAS, MLGU Jones is set to enter in a Loan Agreement with the Land Bank of the Philippines, securing an amount of Two Hundred Fifteen Million Pesos (Php215,000,000.00) to be utilized for the following projects provided in their Ordinance as follows:

| Term Loan 16 | Up to P166,000,000.00 contract price, whichever is lower but shall not be more than the NBC of the LGU BLGF certification. | Road, Drainage System and Hanging Bridge construction as follows: 1. Concreting of Farm-to-Market Road (13.082 kms) - P150.00 Million. 2. Construction of Drainage System in Brgy. 2 and Brgy. Lacab - P10.00 Million. 3. Construction of Minuri Hanging Bridge- P6.00 Million. |

WHEREAS, section 297(a) of the Local Government Code allows local government units to contract loans, credits, and other forms of indebtedness with any government or domestic private bank and other lending institutions to finance the construction, installation, improvement, expansion, operation, or maintenance of public facilities, infrastructure facilities and the implementation of other capital investment projects, subject to such terms and conditions as may be agreed upon by the local government unit and the lender;

WHEREAS, this Honorable Body recognizes that local government units possess direct information concerning the needs of their citizens and the conditions within their jurisdiction and thus have the appropriate standing and capacity to identify the programs, projects, and activities that will further the welfare of their people;

A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2023-20 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF JONES, ISABELA AS INTRA VIRES

WHEREAS, after careful review and with due consideration to the recommendation of the Provincial Budget Office interposing no objection and stating no adverse finding to the Ordinance No. 2023-20 of the MLGU Jones, Isabela, this Honorable Body finds that the said ordinance is a valid exercise of the legislative powers of their sanggunian and within the authority of MLGU Jones, Isabela as prescribed by law subject to compliance with the budgetary limitations for debt servicing as provided in Section 324 of the Local Government Code;

WHEREFORE, upon motion of the Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2023-20 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF JONES, ISABELA AS INTRA VIRES.
