WHEREAS, one of the key policies and aspirations of the PGI to enhance the quality of education by fostering partnerships with educational institutions to complement classroom learning with real-world experiences;

WHEREAS, the Isabela National High School (INHS), in its Letter dated 02 February 2024, has expressed its intention to establish a Work Immersion Partnership for its five hundred (500) Senior High School Students for S.Y. 2023-2024;

WHEREAS, as part of the course requirements of the K to 12 program, Grade 12 Learners are mandated to undergo work immersion in a business organization or establishment to apply the theories and principles learned in school effectively;

WHEREAS, the INHS has acknowledged the exceptional facilities, expertise, and conducive work environment of the PGI, thereby designating PGI as its preferred Work Immersion Venue/Industry Partner;

WHEREAS, the well-trained workforce of PGI further enhances its suitability as a partner for INHS in facilitating effective learning experiences for the students participating in the Work Immersion Program;

WHEREAS, recognizing the importance of aligning with the objectives of the K to 12 Program of the Department of Education, it is imperative to formalize the partnership between the PGI and the INHS through a Memorandum of Agreement;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after a careful review of the said MOA, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the PGI;

WHEREFORE, premises considered, upon motion of the Honorable Mary Grace D. Arreola, duly approved and seconded in a session duly assembled, it was –
