A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T. ALBANO III, TO EXECUTE A DEED OF DONATION ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA WITH THE SCHOOLS DIVISION OFFICE OF CITY OF ILAGAN FOR THE DONATION OF SCHOOL BUILDINGS AND STRUCTURES

WHEREAS, the Provincial Government of Isabela (PGI) and the Department of Education share a common objective and are jointly committed to promoting and enhancing quality education through collaborative efforts and initiatives within the Province of Isabela;

WHEREAS, in accordance with the General Welfare Clause of the Local Government Code of 1991 and Republic Act No. 9155 (Governance of Basic Education Act of 2001), the PGI has undertaken the construction of numerous school buildings and structures across the Province;

A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T. ALBANO III, TO EXECUTE A DEED OF DONATION ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA WITH THE SCHOOLS DIVISION OFFICE OF CITY OF ILAGAN FOR THE DONATION OF SCHOOL BUILDINGS AND STRUCTURES

WHEREAS, these school buildings and structures have been utilized by the beneficiaries and end-users for the benefit of Isabeleño learners, despite the absence of formal documentation transferring ownership;

WHEREAS, a recent observation by the Commission on Audit (COA) has recommended that the PGI pursue and administer the transfer of ownership, accountability, and reporting of these school buildings and structures to the school-beneficiaries to accurately represent PGI's Property, Plant, and Equipment (PPE) in its Statement of Financial Position;

WHEREAS, in alignment with the COA observation and in compliance with legal obligations, the PGI intends to execute a Deed of Donation with the Schools Division Office of City of Ilagan (SDO-City of Ilagan), encompassing the transfer of ownership of the school buildings and structures described in Annex "A" of the Deed referenced in this resolution;

WHEREAS, the collaboration between the PGI and SDO-City of Ilagan through the execution of the Deed of Donation is crucial to facilitating the successful implementation of the COA observation and recommendation;

WHEREAS, submitted for the review and approval of this August Body is the Deed of Donation, to be entered into between the PGI and the SDO-City of Ilagan, concerning the donation of school buildings and structures, and providing the responsibilities of both parties;

WHEREAS, after careful review of the said Deed of Donation, this August Body determined that such is just, lawful, and provides the necessary safeguards to ensure the proper transfer of ownership and accountability of the school buildings and structures, thereby upholding the interests of both the Provincial Government of Isabela and the school-beneficiaries;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

NOW THEREFORE, upon motion of the Honorable Mary Grace D. Arreola, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T. ALBANO III, TO EXECUTE A DEED OF DONATION ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA WITH THE SCHOOLS DIVISION OFFICE OF CITY OF ILAGAN FOR THE DONATION OF SCHOOL BUILDINGS AND STRUCTURES.

RESOLVED FINALLY, that a copy of this resolution be furnished to Honorable Governor Rodolfo T. Albano III for his information.


