WHEREAS, the support and cooperation of the Honorable Members of the House of Representatives from the Province of Isabela are indispensable in advancing this vital initiative and securing the requisite resources for its realization;

WHEREFORE, upon motion of the Honorable Edgar R. Capuchino, duly approved and seconded in a session duly assembled, it was –
