A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 2023-356 (2024 ANNUAL BUDGET) IN THE TOTAL AMOUNT OF TWO HUNDRED TWENTY FOUR MILLION EIGHT HUNDRED SEVENTY EIGHT THOUSAND NINE HUNDRED FIVE PESOS (P224,878,905.00) OF THE MUNICIPALITY OF ANGADANAN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Ordinance No. 2023-356, an Ordinance authorizing the Annual Budget of Angadanan, Isabela for Fiscal Year 2024 in the total amount of **TWO HUNDRED TWENTY FOUR MILLION EIGHT HUNDRED SEVENTY EIGHT THOUSAND NINE HUNDRED FIVE PESOS (P224,878,905.00)** covering the various expenditures for the operation of the Municipal Government of Angadanan, Isabela and appropriating the necessary funds for the purpose, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements, general limitations and other provisions set forth under Republic Act No. 7160:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2023-356 (2024 Annual Budget) of the Municipality of Angadanan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160 and subject further to the following conditions:

1. The lumpsum appropriation for compensation adjustment in the amount of Three Million Three Hundred Sixty Five Thousand Pesos (P3,365,000.00) shall be covered with appropriate legal basis and implementing guidelines to be released by the Department of Budget and Management;
2. The positions under the **Angadanan Integrated Community Hospital (AICH)** shall be in accordance with DBM-DOH Joint Circular No. 2013-1 dated September 23, 2013, on the Revised Standards on Organizational Structure and Staffing Pattern of Government Hospitals, CY 2013 Edition;
3. The Following positions under the Plantilla of Personnel of Angadanan Integrated Community Hospital is not consistent with the created positions under Section 4.5.a of Appropriation Ordinance No. 2023-356 dated November 6, 2023, to wit:

4. The following Plantilla positions shall be converted to generic class titles in accordance with DBM Local Budget Circular No. 137 dated July 13, 2021, on the Index of Occupational Services, position Titles and Salary Grades in the Local Government (IOS-LGU), CY 2021 Edition, to wit:

5. The appropriation for **Hazard Pay** under the Municipal Social Welfare & Development Office in the amount of Thirty Nine Thousand One Hundred Eleven Pesos & 55/100 (P39,111.55) shall be in accordance with DSWD Memorandum Circular No. 05, S. 2022 and the DBM-DSWD Joint Circular No. 1, s. 2018 dated December 1, 2018 on the Rules and Regulations on the Grant of Compensation-Related Magna Carta Benefits to Public Social Workers (PSWs) as supported by AO No. 05, S. 2023 and AO No. 06, S. 2023;
6. The appropriation for **Legal Services, Other Professional Services and Other General Services** in the amount of Fifty Thousand Pesos (P50,000.00), Five Million One Hundred Seventy Eight Thousand Pesos (P5,178,000.00) and Twelve Million Six Hundred Four Thousand Four Hundred Seventy Five Pesos (P12,604,475.00) respectively, shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, on the Description of Accounts under the Revised Chart of Accounts for Local Government Units and must be governed by the provisions of Republic Act 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations;
7. The **Subsidy to Solo Parents** in the amount of One Million One Hundred Twenty Five Thousand Pesos (P1,125,000.00) shall be in accordance with Section 17 (b) (2) (iv) of RA No. 7160, and Section 12 of RA No. 11861 on the Expanded Solo Parents Welfare Act as supported by Local Budget Memorandum No. 87 dated June 9, 2023, and shall be implemented with the guidelines to be issued by the DILG;
8. The utilization of 5% LDRRMF shall be in accordance with the approved Local Disaster Risk Reduction and Management Plan pursuant to RA 10121 and its implementing Rules and Regulations, as supplemented by

NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013. Provided further, that the LDRRMF Plan shall be reviewed by the Office of Civil Defense (OCD) pursuant to RA 10121 and its implementing Rules and Regulations as supplemented by Local Budget Memorandum No. 87 dated June 19, 2023 and finalized by Local Budget Memorandum No. 87-A dated December 28, 2023, copy furnish the Office of the Sangguniang Panlalawigan of the reviewed LDRRMF;

9. The appropriation for the 20% Development Fund shall strictly cover only the development projects prescribed and authorized under DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020 as supplemented by DBM-DOF-DILG Joint Memorandum Circular No. 1 dated April 27, 2023;
10. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations. Further, the acquisition of Transportation Equipment (Elf Type Boom Truck) in the amount of Three Million Pesos (P3,000,000.00) shall be subject to the provisions of Budget Circular No. 2022-1 dated February 11, 2022 on the Omnibus Guidelines on the Acquisition, Use, Rental, and Replacement of Government Motor Vehicles;

RESOLVED FURTHER, to require the Municipality of Angadanan, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to furnish the Municipality of Angadanan, Isabela that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the Municipal Mayor, **Honorable JOELLE MATHEA S. PANGANIBAN**, and to the Sangguniang Bayan of the Municipality of Angadanan.
