WHEREAS, Section 3 of Executive Order No. 221, Series of 2003, amending Executive Order No. 15, S. 1998 entitled, “Redirecting the Functions and Operations of the Department of Social Welfare and Development” mandates the Department of Social Welfare and Development (DSWD) to implement the crisis intervention;

WHEREAS, the DSWD is the leader in social protection that continuously implements the Assistance to Individuals in Crisis Situation (AICS) Program to support government efforts in providing aid to individuals and families seeking assistance;

WHEREAS, the AICS Program serves as a stop-gap measure to support the recovery of individuals and families suffering from unexpected life events or crises;

ALBANO III, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, TO ENTER, SIGN AND EXECUTE A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR THE IMPLEMENTATION OF ASSISTANCE TO INDIVIDUALS IN CRISIS SITUATION (AICS)

WHEREAS, to ensure the faster and more efficient delivery of assistance through the AICS Program to the increased number of clients, the DSWD issued Memorandum Circular No. 16, Series of 2022, *"Revising the Guidelines on the Implementation of the Assistance to Individuals in Crisis Situation"*;

WHEREAS, said Memorandum provides for the different modes of disbursement strategies, such as the transfer of funds to local government units;

WHEREAS, the Provincial Government of Isabela is mandated by law to discharge basic services, including social welfare services to the poor, vulnerable and marginalized sectors that needs the assistance and support of the government during a crisis situation;

WHEREAS, to avail the benefits under M.C. No. 16, S. 2022, the execution of a Memorandum of Agreement between the Provincial Government of Isabela (PGI) and the Department of Social Welfare and Development (DSWD) is required;

WHEREAS, under Section 465, (b) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Margarett U. Chin, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T. ALBANO III, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, TO ENTER, SIGN AND EXECUTE A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR THE IMPLEMENTATION OF ASSISTANCE TO INDIVIDUALS IN CRISIS SITUATION (AICS).
