WHEREAS, to address the social dilemma on drug dependency, the Department of Health – Drug Abuse Treatment and Rehabilitation Center Region 02 (DOH-DATRC) was established in Brgy. Centro, San Antonio, Ilagan City, Isabela;

WHEREAS, DOH-DATRC aims to produce more transformed patients and continue to provide affordable, quality and sustainable rehabilitative programs and services in partnership with other agencies towards the realization of its goal and for the fulfillment of its mandate;

WHEREAS, in line with this, the Provincial Government of Isabela (PGI), thru the Provincial Government-Owned Hospital, Governor Faustino N. Dy Sr. Memorial Hospital (GFNDSMH), signifies its intention to provide dental, laboratory, radiology, and medical-surgical services to inpatients, outpatients and aftercare patients (ACP);

WHEREAS, it is recognized that the collaboration between the Provincial Government of Isabela (PGI) and the Department of Health-Drug Abuse Treatment and Rehabilitation Center Region 02 (DOH-DATRC) is not only crucial for the successful provision of services to individuals affected by drug dependency but also vital for the sustainability of such efforts on an annual basis;

WHEREAS, acknowledging the need for continuity and consistency in service provision, it is imperative to specify that this Memorandum of Agreement for Fiscal Year 2024, ensures clarity and alignment with the annual budgetary cycles and operational planning of both parties;

WHEREAS, desirous to avail the services of the PGI, the proposed Memorandum of Agreement between the Provincial Government of Isabela (PGI) and the Department of Health-Drug Abuse Treatment and Rehabilitation Center Region 02 (DOH-DATRC) has been submitted for the review and approval of this Honorable Body;

WHEREAS, after a careful review, this August Body deems the Memorandum of Agreement between the Provincial Government of Isabela and the DOH-DATRC to be just and lawful;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents relative to the execution of his functions, upon authority vested upon him by the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was—
