**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

**NOW THEREFORE**, on motion of **SP Member EDGAR R. CAPUCHINO** duly seconded:

**THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:**

**RESOLVED**, to declare Appropriation Ordinance No. 08-2023 (Supplemental Budget No. 5 FY 2023) of the Municipality of Burgos, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. The utilization of the PPAs to be funded from the 20% share of LGUs in the proceeds collected from the FYs 2018, 2020, and 2021 of Fire Code Fees amounting to One Hundred Forty Three Thousand One Hundred Twenty Nine Pesos & 93/100 (P143,129.93) shall be subject to the provisions of DOF-DBM-DILG Joint Circular No. 2015-01 dated February 12, 2015 as revised by DBM-DILG-DOF Joint Circular No. 2023-01 dated April 17, 2023;
2. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations. Further, the purchase and specifications of the motor vehicle shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018 and Budget Circular (BC) No. 2022-1 dated February 11, 2022, and BC No. 2022-1A dated March 1, 2023.

**RESOLVED FURTHER**, to require the Municipality of Burgos, Isabela to comply with the herein conditions.

**RESOLVED FURTHERMORE**, to inform the Municipality of Burgos, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable ISIS DOMINIQUE T. UY**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Burgos, Isabela through the **Honorable RUBEN A. GRAGASIN**, Municipal Vice-Mayor.
