WHEREAS, Appropriation Ordinance No. 27 Series of 2023, an Ordinance authorizing Supplemental Budget No. 11 FY 2023 of the Local Government Unit of Quirino, Isabela amounting to **TWO MILLION THREE HUNDRED SEVENTY FOUR THOUSAND PESOS (P2,374,000.00)** derived from PS savings for the grant of Service Recognition Incentive to officials and employees of the Municipality of Quirino, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 27 S. 2023 of the Municipality of Quirino, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following condition:

1. The appropriation for the grant of Service Recognition Incentive (SRI) in the amount of Two Million Three Hundred Seventy Four Thousand Pesos (P2,374,000.00) shall be in accordance with Administrative Order No. 12 dated December 7, 2023 and DBM Budget Circular No. 2023-2, dated December 13, 2023, on the Guidelines on the Grant of Service Recognition Incentive to Government Employees for FY 2023;

RESOLVED FURTHER, to require the Municipality of Quirino, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of Quirino Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable EDWARD D. JUAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Quirino, Isabela through the **Honorable VICTOR EMMANUEL G. CALLANGAN**, Municipal Vice-Mayor.
