**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2023-002 (SUPPLEMENTAL BUDGET NO. 01 CY 2023) IN THE AMOUNT OF ONE MILLION SIX HUNDRED THIRTY TWO THOUSAND NINE HUNDRED SEVENTY SEVEN PESOS & 82/100 (P1,632,977.82) OF THE MUNICIPALITY OF ECHAGUE, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS**

**WHEREAS**, Appropriation Ordinance No. 2023-002, an ordinance approving Supplemental Budget No. 01, Calendar Year 2023, of the Local Government Unit of Echague, Isabela, appropriating the amount of **ONE MILLION SIX HUNDRED THIRTY TWO THOUSAND NINE HUNDRED SEVENTY SEVEN PESOS & 82/100 (P1,632,977.82)** to fund the position of Rural Health Physician, LDRRM Assistant, and for other purposes of the Municipality of Echague, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

**NOW THEREFORE**, on motion of **SP Member EDGAR R. CAPUCHINO** duly seconded:

**THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:**

**RESOLVED**, to declare Appropriation Ordinance No. 2023-002 (2023 Supplemental Budget No. 01) of the Municipality of Echague, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The creation of positions shall be consistent with the rules and regulations as prescribed under CSC Memorandum Circular No. 12, series of 2022. Further, creation of non-mandatory positions and offices in LGUs may be allowed subject to the following conditions:
  - a. That they are priority needs as identified by the LCE, the Sanggunian and/or LDCs concerned consistent with Section 17 of RA No. 7160;
  - b. All mandatory positions stipulated under RA No. 7160 and other pertinent laws have been created and provided;
  - c. The SSL has been fully implemented;
  - d. The general limitations on PS expenditures are not exceeded;
  - e. The classification of the positions is consistent with the standards and implementing rules and regulations of RA No. 6758;
2. Giving emphasis likewise to the clarification between the positions of Municipal Health Officers (MHOs) and Rural Health Physicians (RHPs) provided under Item 9.2.1.5 of the Manual on the Position Classification and Compensation Scheme (MPCCS) in LGUs under Circular Letter No. 2007-6 dated February 19, 2007 which states that:

*9.2.1.8 Municipal Health Officers (MHOs) and Rural Health Physicians (RHPs)- The MHO as a mandatory position is the municipal department head in charge of formulating and implementing the health and medical programs for the whole municipality. It assumes supervision, coordination and monitoring of rural health units (RHUs) within the municipality. The RHP is ordinarily in charge of a small medical team of health service personnel assigned in a RHU which renders preventive and medical services in specific area of assignment within the municipality, usually consisting of at least one (1) barangay. Notwithstanding that the RHP pursuant to RA No. 7305 is given the same salary grade as the*

***MHO, the MHO has ascendancy over the RHP in the hierarchical ranking of positions in LGUs.***

3. The utilization of Terminal Leave Benefits in the amount of Two Hundred Thousand Pesos (P200,000.00) shall be in accordance with DBM Budget Circular No. 2016-2 dated March 29, 2016, on the Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, and CSC Memorandum Circular No. 02, s. 2016, on Amendment to the Constant Factor in the Formula used for Computing Terminal Leave Benefits (Section 40) and Computation of Leave Monetization (Section 24) of the Omnibus Rules on Leave;
4. The appropriation for Overtime and Night Pay in the amount of Two Hundred Fifty Five Thousand Five Hundred Twenty Three Pesos & 12/100 (P255,523.12) shall be in accordance with the guidelines of CSC-DBM Joint Circular No. 2, series 2015 dated November 25, 2015, on the Policies and Guidelines on Overtime Services and Overtime Pay for Government Employees;

**RESOLVED FURTHER**, to require the Municipality of Echague, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

**RESOLVED FURTHERMORE**, to inform the Municipality of Echague, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable FRANCIS FAUSTINO A. DY**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Echague, Isabela through the **Honorable ALLAN P. TUPONG**, Municipal Vice-Mayor.
